Driving licence:

A driver's license may not have a geographic limitation or bear designations or inscriptions that indicate a possible geographic limitation. A Passport/ID must also be provided.

This also applies to use of the vehicle on islands within these countries (except for the Azores, Canary Islands, Madeira and overseas territories). The use of the vehicle in Croatia, Czech Republic, Hungary, Slovakia and Slovenia is only permitted with the prior consent of the Lessor and conclusion of a cross-border surcharge and must be stated on the rental agreement.
